Sub: Delegation of powers to GMs of Zonal Railways & Production Units for nominating officers for foreign technical training/visits

Chairman Railway Board has approved that General Managers of Zonal Railways and Production Units and DG/RDSO, with the concurrence of Principal Financial Adviser are empowered to depute staff and officers up to Selection Grade level for foreign technical trainings/visits specific to various technology collaboration/transfer of technology/equipment testing specific training and inspection against a specific provision in the contracts administered/entered into by the Zone/PU/RDSO. The maximum deputation for an individual at a stretch can be for five working days. Extant rules applicable for such foreign training/visits will however be followed. While exercising this power, GM/DG will take adequate care to ensure the need for the visit and keep Secretary Railway Board informed.

A copy of each foreign visit approved by GM/DG shall be marked to Secretary, Railway Board for information.
