

This office letter of even no. dated 31.1.2018 on the above subject stands modified as under:

2. For foreign technical trainings/visits of staff and officers upto Selection Grade, specific to various technology collaboration/transfer of technology/equipment testing specific training and inspection against a specific provision in the contracts administered/entered into by the Zone/PU/RDSO, General Managers of Zonal Railways and Production Units and DG/RDSO will send nomination proposals duly concurred by Principal Financial Adviser to Secretary Railway Board for further necessary action. In all such cases, the maximum deputation for an individual shall be for five working days. While sending proposals, GM/DG will take adequate care to ensure that the essentiality/need for the foreign visit has been specifically considered.

3. The above issues with the approval of FC & CRB.


