रेल्वे बोर्ड के पत्र सं. 2017/Trans/01/Policy दिनांक 07.02.2018 की प्रति सूचना, मार्गदर्शन तथा आवश्यक कार्यवाही हेतु प्रकाशित की जा रही है।

Earlier in terms of Board's letter No. 2017/Trans/01/Policy dated 18.10.2017 [Estt. Rule No. 205/2017, powers were delegated to DRMs for Inter-Railway transfers of staff on own request and on mutual basis.

Board, vide letter No. 2017/Trans/01/Policy dated 07.02.2018, has clarified that above mentioned power of inter-railway/inter-division transfer of staff given to DRMs is to be exercised only for mutual transfer cases on the basis of own request of employees.

Accordingly, it is clarified that powers have been delegated to DRMs for inter-railway transfer of staff in respect of transfers on mutual basis only. Hence, instructions issued vide Estt. Rule No. 232/2017 are hereby withdrawn. The Inter-railway Transfer cases on own request will be dealt at HQ's level as were hitherto being done.

This issues with the approval of PCPO.

This also disposes Sr. DPO/NGP's letter No. P/NGP/RUL/2014/08 dated 12.02.2018.


