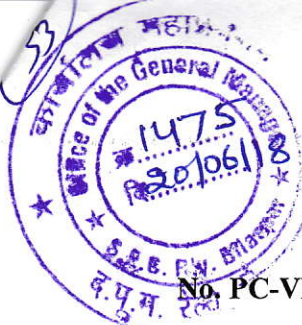

**Sub:** Clarification regarding exercise of option for switching over to 7<sup>th</sup> CPC from the date of promotion falling after the date of notification i.e. 28.07.2016.

Consequent to promulgation of RS(RP) Rules, 2016, notifying the 7<sup>th</sup> CPC pay structure, several doubts have been raised by a Railway as to whether while exercising the option to switch over to 7<sup>th</sup> CPC, such option can be exercised to be effective from next promotion.

2. In this context, it is advised that modalities to deal with above are already given in Rule 5 & 6 of RS(RP) Rules, 2016. The Option Form (Rule 6(2)) under proviso to Rule 5 permits the employee to continue in existing pay structure till date of promotion/upgradation. If such an option is exercised within the stipulated time as per Rule 6 of RS(RP) Rules, 2016, the same shall be valid and acceptable. However, in this scenario, the employee will continue in the 6<sup>th</sup> CPC pay structure till the date of promotion/upgradation and will not be eligible for any arrears and option once exercised shall be final.
