रेल्वे बोर्ड के पत्र सं. E(NG)II/2016/RR-2/1 दिनांक 14.06.2018 की प्रति सूचना, मार्गदर्शन तथा आवश्यक कार्यवाही हेतु प्रकाशित की जा रही है।

Vide this office letter dated 31.05.2017, clarification was sought from Board that whether there is any restriction to become member of more than one State of Scouts. It is not clear whether the candidate who is a member of more than one state of Scouts simultaneously is eligible for employment on Railways against Scouts & Guides quota.

Board vide letter above have clarified the issue that no one can be a member of two State Associations at the same time or simultaneously.

In view of above, it is advised that in future, this clause should be clearly mentioned in the notification for recruitment against Scouts & Guides Quota and a declaration in this regard should be obtained from each applicant.
