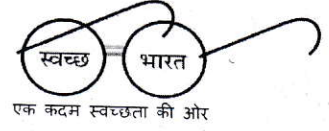

Sub: Change in the Designation of PHODs and CHODs in Zonal Railways/PUs

Attention is invited to letters mentioned above wherein it was decided to change the designation of PHODs and coordinating HODs by prefixing the word Principal as PCME, PCPO etc. in HAG/SAG of all departments of Zonal Railways/PUs working under GM except the Construction Organization and other Organization.

2. It is clarified that wherever a PHOD/CHOD is posted under a GM of Zonal Railway/PU the designation would be prefixed with the word Principal irrespective of the fact that there is only one SAG officer in the concerned Department of that Unit (Railway/Production Unit) i.e. the designation of PCME, PCPO etc. is also to be used in Production Units headed by GM.
