

Sub: Delegation of Powers to ADRMs by DRMs

Issue of delegation of powers to ADRMs was raised during CRB's meeting with divisional officers on 18th June 2018 at Mumbai. Accordingly, Board (CRB) has approved the following:

“Divisional Railway Managers can delegate only administrative powers to any of the ADRMs based on their administrative necessity. Financial powers, however cannot be delegated except for commercial matters”

DRMs shall use their own wisdom while delegating such powers based on the workload of various ADRMs.
