




**Sub: Implementation of instructions issued from Railway Board**

2. The following has been approved by CRB:

*"Instructions issued from Railway Board with the approval of Competent Authority interalia including process reforms and empowerments, should be implemented with immediate effect from the date of issue of the instructions, unless otherwise specified. In case the instructions involve modification in Schedule of Power of a Zonal Railway, the instruction may take effect without waiting for a formal correction slip. The necessary correction slip should be issued within reasonable time".*


