Sub: Permission to retain Railway accommodation at the previous place of posting to Railway officers / staff going on deputation to Nagpur Metro Rail Corporation Ltd (NMRCL).

Ref: Railway's letter No. P-HQ/RUL/113/2/993 dated 14.02.2018

Please refer to the Railway's letter cited above requesting to clarify the following:-

- (1) Permissible period of retention of Railway accommodation in favour of officers/staff going on deputation to 'Nagpur Metro Rail Corporation Ltd'.
- (2) The retention period for officers/staff going on deputation to such SPVs/organisations which are joint venture of Government of India and concerned State Governments.

As per extant policy, retention of quarters by Railway officers going on deputation to non-railway PSUs is permitted only for two months on payment of normal rent and any retention thereafter is treated as unauthorised liable for recovery of damage / penal rent and for institution of eviction proceedings as per law.


2. The above rule applies to Nagpur Metro Rail Corporation Limited (NMRCL) also which is a Joint Venture project of Government of Maharashtra and the Government of India (Ministry of Urban Development), a non-railway PSU. No relaxation has been given to NMRCL by Board in the matter of retention of railway accommodation.
