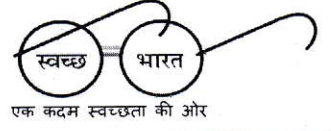


Sub:- Transfer of officers on promotion.

Ref:- Comprehensive Transfer Policy for Railway Officers issued vide
this Ministry's letter of even number dated 31.08.2015. 145/15

As per para 1 (xiv) of the Comprehensive Transfer Policy for Railway Officers issued on 31.08.2015, "the Controlling officers will ensure that the officer transferred will be relieved within a maximum period of one month." However, of late, it has been seen that Railway officers who are transferred from one Zone/Unit to another on promotion do not carry out their orders within the stipulated period and try to evade/delay the process by citing one reason or the other. This causes a lot of administrative difficulties not only for the railway/unit where the officer stands transferred but also for the Zone/Unit where the officer continues to remain even after issue of transfer orders. Board has taken a serious view of this matter.

2. In order to overcome the administrative difficulties being faced in this regard and also to curb the rising tendency among the officers of not carrying out their transfer/promotion orders, it has been decided that if an officer does not comply with his/her transfer-cum-promotion order within the stipulated period, it may be treated to be a refusal for promotion and may render the officer liable for debarment from such promotion for a minimum period of one year.

3. These instructions will come into force with immediate effect and may be brought to the notice of all concerned.
