

Sub:- Delegation of power to grant extension under Junior/Senior Residency Scheme and DNB trainees as per NBE guidelines in Railway Hospitals – regarding.

In terms of extant instructions, for engagement of Jr. /Sr. Residents under Residency Scheme and DNB/FNB trainees under National Board of Examinations (NBE) guidelines, the sanction of initial engagement and subsequent extensions from time to time is done with the approval of Competent Authority in Ministry of Railways for which zones have to send the proposal for extension of engagement seeking approval for the same from time to time. The need for simplifying the procedure of extension of such schemes has been engaging attention of the Board for some time.

The matter has been examined in consultation with Finance Directorate.

After detailed deliberation in the matter, it has been decided that first/initial sanction of scheme of engagement of Jr. Residents/Sr. Residents under Residency Scheme of Govt. of India and engagement of DNB /FNB seats under the scheme of National Board of Examinations (NBE) will be given by Railway Board and extension of the same will be granted by the General Managers of the zone without referring the proposal to Railway Board.

This has the approval of Finance Directorate of Ministry of Railways.




