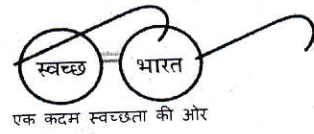



**Sub: - Engagement of Retired Railway/ Government Doctors as Contract Medical Practitioners (CMPs) - Revision of Terms & Conditions.**

In terms of Board's letter No.2008/E(GR)II/1/1 dated 16.07.2012, it was decided that to meet the shortage of doctors, in addition to the scheme of engagement of Medical Practitioners from open market as CMPs, retired railway doctors upto the age of 65 years shall also be engaged as Contract Medical Practitioners against existing regular vacancies on a fixed remuneration of Rs. 46,000/- p.m. (subject to the condition that remuneration + pension drawn by retired railway doctor should not exceed the last pay drawn). Further, in terms of Board's letter No.2013/E(GR)II/1/5 dated 20.05.2014 the maximum number of annual terms of engagement of retired Railway/Government Doctors was raised from TWO to FIVE subject to the age limit of 65 years.

2. In view of instructions issued by the nodal Ministry, i.e., Ministry of Health & Family Welfare, and requests received from some Zonal Railways, Board and Hon'ble Minister of Railways, have now decided the following:-

- (i) The number of annual terms of engagement of Retired/Government doctor engaged as CMPs, is revised from the existing FIVE to SEVEN subject to attain the age limit of 67 years, whichever is earlier and each term of engagement shall not exceed more than one year.
- (ii) Ministry of Railways have decided to review the rate of remuneration payable to retired Railway/Government Doctors engaged as CMPs laid down in Board letter No. 2008/E(GR)II/1/1 dated 16.07.2012 and it has been decided that the remuneration of Retired Railway/Government doctors engaged as CMPs shall be revised as under, subject to the condition that remuneration plus pension shall not exceed the last pay drawn:-

Retired Doctors as CMPs (Full time)	Monthly Remuneration (in Rs.)
GDMO	75,000/-
Specialist (1 <sup>st</sup> Year)	95,000/-
Specialist (2 <sup>nd</sup> Year onwards)	1,05,000/-
Super Specialist	1,15,000/-


