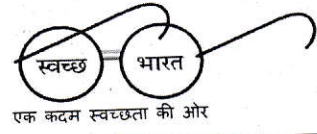



As per extant instructions issued from time to time, filling up the vacancies of Additional Registrar, Assistant Registrar and Assistant Financial Adviser in Benches of Railway Claims Tribunal (RCT), is primarily the responsibility of Zonal Railways under whose geographical jurisdiction the RCT Bench is situated. However, it has been observed that these vacancies are not filled for long which has hampered the smooth functioning of RCT.

2. Keeping in view the difficulty faced by concerned Zonal Railways in filling up the sanctioned posts of Officers (Gazetted) in respective Benches RCT, Board have decided to allow filling up the vacancies of the sanctioned posts of RCT including the posts of Additional Registrar, Assistant Financial Adviser, Assistant Registrar and PS-I (one post in Principal Bench, Delhi) in different Benches of RCT from amongst serving Railway Officers working in any Zone/Division of Indian Railways and Railway PSU's on transfer on tenure basis without restriction to territorial jurisdiction.

3. Zonal Railways are requested to fill the vacant posts of Officers in RCT as and when they occur from among the serving Railway Officers in their Zones. They may also give wide publicity to the vacancies of the Gazetted Officers in RCT for other Zonal Railways/PSU's and ensure to relieve the Officers willing/applying to join any Bench of RCT.
