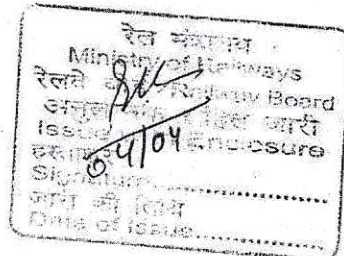

**INDIAN RAILWAY ESTABLISHMENT MANUAL, VOLUME I

ADVANCE CORRECTION SLIP NO.242

The following amendment may be made in Para 1402 of Chapter XIV of Indian Railway Establishment Manual, Volume I (Revised Edition 1989):-

Substitute the last sentence of Para 1402 with the following:

Applications of officers of the Junior Administrative Grade and above in response to vacancies notified by Railway PSUs/ Autonomous Bodies for appointment on deputation basis may be forwarded to the PSUs/ ABs with the approval of the General Manager. Applications of officers of the Junior Administrative Grade and above for deputation to other than Railway PSUs/ AB's may be forwarded to the Railway Board for disposal. Orders for deputation of the officers in all cases shall be issued by the Railway Board.
