
Sub: Permission of Air Travel by officers of IROAF.

Vide letter under reference, CAO/IROAF has made following requests:-

- (i) CAO/IROAF may be authorized to permit entitled officers (HAG/SAG) to travel by Air as per Railway Board's letter No. F(E)/2017/AL-28/41 dated 10.05.2018.

This issues with the concurrence of the Associate Finance of the Transformation Cell.


