Sub: Empowerment of GMs to organize training of officers

1. Board (MS, FC & CRB) have approved the following empowerment to General Managers of Zonal Railways, PUs, CORE and DG/RDSO to provide flexibility in organizing training programs for officials.

(i) Removal of ceiling of Rs 10,000/- per day per person within the overall delegation of Rs 50,000/- per person per training course available with GMs for organizing training to railway employees (gazetted & non gazetted both) from outside institutions (as per Railway Board Letter No 2017/Trans/01/Policy dated 18.10.2017). 20/12

Similarly the ceiling of Rs 8,000/- per day per person is removed within the overall delegation of Rs 40,000/- per person per training course available with DRMs for organizing training of non-gazetted employees from outside institutions.

(ii) GMs are empowered to invite visiting lecturers and grant them honorarium, travelling facilities with permission for air travel to eminent visiting faculty and boarding and lodging and local transport facility to visiting lecturers at par powers available with DG/NAIR in Model SOP 2018, Part C - Item 74 (A), (B) & (C).

However, for payment of honorarium, there shall be annual ceiling of Rs 4 lakhs for each GM (zonal Railway, PU, CORE, DG/RDSO). This power may be exercised with personal approval of GM.

2. This issues with the concurrence of Associate Finance of Transformation Cell, Railway Board.
