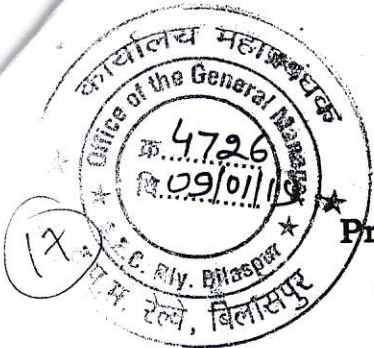

Board's office vide letter under reference the entitlement of hospital wards for Railway beneficiaries in Railway empanelled hospitals was revised keeping in view the guidelines of Ministry of Health & Family Welfare pursuant to acceptance of 7th CPC.

However, various representations were received in this office seeking clarification whether the entitlement of hospital wards in Railway empanelled hospitals for Railway beneficiaries is to be determined as per the corresponding Basic Pay drawn by the officer in 7th CPC per month or as per the Pension drawn in 7th CPC per month.

Since, Ministry of Railways is following the same criteria for determining the entitlement of hospital wards in empanelled hospitals as of Ministry of Health & Family Welfare, therefore, it is again reiterated that entitlement of hospital wards in empanelled hospitals is to be determined as per the 'Corresponding Basic Pay drawn by the officer in 7th CPC per month' as mentioned in Board's letter of even no. dated 08.05.2018.
