N.B- 1 The above Track Maintainer Gr.-IV so transferred to other department shall be eligible for counting half the length of continuous service for seniority in the new cadre in which they are to be absorbed. The above pay band and grade pay allotted is nothing to do with the pay band and grade pay already granted to the above staff under MACP and they will be continued to draw the same in their new unit/department.


2. The above staff should be free from D&A/SPE/Vig cases at the time of releasing. The staff who are undergoing punishment of stoppage of increment etc shall be transferred to other department with the condition that they have to complete remaining punishment in the new cadre/department.

3 The employees who have been considered for the post of Porter in Operating department have to undergo initial induction training at the prescribed training centre, only after training their place of posting should be decided. They should be released to this office with proper identification for further course of action at this regard .

4. Concerned cadre dealer has to process for place of posting of the remaining employees and issue transfer orders accordingly.

5. It should be noted that only after issuance of transfer orders from the respective cadre section and fulfilling other stipulated conditions, the above employees should be released to their new place of posting.

6. Major penalty charge sheet is pending against staff at Sl. No. 2 & 8. Hence, they can only be released after finalization of DAR cases. Concerned Disciplinary Authority to finalise the DAR case at the earliest.


