

- The Promotion order is implemented subject to condition that above staff are free from SPE/VIZ/ D&A/COURT cases and they are not going for any punishment for stoppage of increment/ reduction of pay as on date.
- Pay will be fixed as per extant Rules.
- The Vacation/retention of Railway Quarters if any shall be dealt as per extant rules. The date of changes should be intimated to this office.
- Option for pay fixation may be exercised within a month as per extant rule if they desire so.
- The above order should be carried out within 30 days from the date of issue of the order. At the end of 30 days, if the above staff has not carried out the promotion order, they should be informed to branch officer that they are being debarred for promotion.
- If the staff have not carried out the promotion order at the same station, the disciplinary action should be taken as per para (iii) of Rule No. 224 of IREM Vol-1.
- The above promotion order will take effect with immediate effect ie. from the date of taking over charge in higher responsibility.
- In terms of Estt Rule No. 72/2017, promotion of the above employees is purely provisional and shall be subject to the final outcome of main SLP(c)no 4831/2012 pending before the Hon'ble Supreme Court.
