Note:

1. The above named staff is empanelled for promotion to the post of Tech-I in Pay Matrix Level-5 vide this office O. O. No. RPB/2203/2017 Dt.27.12.2017,
2. As the above named staff was not completed two years regular service in existing grade i.e. in Tech.-II therefore his promotion order was not issued. Now, this is issued on completion of his two years regular service in Tech.-II on 03.07.2019.
3. The promotion order is implemented subject to condition that above staff are free from SPE/VIZ/D&A/COURT cases and they are not going for any punishment or stoppage of increment, reduction of pay as on date.
4. Pay will be fixed / option of the pay fixation as per extent rules. If they desire so.
5. The vacation / retention of Railway Quarters if any shall be dealt as per extant rules. The date of changes should be intimated to this office.
6. The above order should be carried out within 30 days from the date of issue of the order. At the end of 30 days, if the above staff have not carried out the promotion order, they should be informed to branch officer that they are being debarred for promotion.
7. If the staff have not carried out the promotion order at the same station, disciplinary action should be taken as per para (iii) of Rule No. 224 of IREM Vol-I.
8. In terms of Estt Rule No.150/2014, promotion of the above employees is purely provisionally and shall be subject to the final outcome of main SLP(C) no.4831/2012 pending before the Hon'ble Supreme Court.
9. If he has got MACPs benefit will get only new designation and no fixation benefit given to them.
