7. If the staff have not carried out the promotion order at the same station, the disciplinary action should be taken as per para (iii) of Rule No. 224 of IREM Vol-1.
8. The above promotion order will take effect with immediate effect i.e. from the date of taking over charge in higher responsibility.
9. In terms of Estt Rule No. 72/2017, promotion of the above employees is purely provisional and shall be subject to the final outcome of main SLP(c)no 4831/2012 pending before the Hon'ble Supreme Court.
