In continuation to this office letters quoted above, the Written Examination for selection to fill up 02(Two) Group "B" posts of Assistant Personnel Officer against 70% Departmental quota, is scheduled to be conducted at **South East Central Railway Mixed Higher Secondary School No.01, Bilaspur (near Railway post office Bilaspur), commencing from 10:30 hrs on 29.09.2019 (Sunday).** The written examination will be of 03 hrs duration. Details of the seating arrangement will be available at the venue. It may be noted that supplementary written examination will be held only, if required, after verification of genuineness of absence.

2. Scheme of Examination: - In accordance with Para 204.1 of IREM (Vol.I), the selection procedure consists of:-

NOTE:-Out of 150 marks, the question relating to the professional subject will carry at least 100 marks. 15 marks out of a total of 150 marks should be set apart for questions on Official Language policy and Official Language Rules. However, attempting these questions will not be compulsory.(SECR's ER No.197/2016).




