Department of Pension & Pensioners' Welfare, Ministry of Personnel, Public Grievances & Pensions vide OM No. 1/20/2018-P&PW(E) dated 18.7.2019 regarding submission of Life Certificate, has conveyed the decision of the Government that Senior Pensioners aged 80 years and above shall be allowed to give their Life Certificate w. e. f. 1st October every year instead of November which would be valid till 30th November of the subsequent year. The remaining pensioners below the age of 80 years may continue to give their Life Certificate in November as per existing provisions.

PART-I(Second Reprint)1997**

The following may be added before the Note in Para 11.1 of Annexure II of Indian Railways Code for the Accounts Department Part - I, (Second Reprint)1997 :

Senior Pensioners aged 80 years and above shall be allowed to give their Life Certificate w.e.f. 1st October every year instead of November which would be valid till 30th November of the subsequent year.

The remaining pensioners below the age of 80 years may continue to give their Life Certificate in November as per existing provisions.
