Board's letter dated 06.07.1998 for granting Accident Free Service Award has been issued after detailed discussions on every matter in the Board's office with the approval of Board (MT, MM, ML, MS, FC and CRB).

In view of above, it is clarified that Board's guidelines issued vide letter No.86/Safety-I/24/35 dtd.06.07.1998 and other instructions issued by the Board from time to time should be followed strictly for granting Accident Free Service Award.
