NOTE

1. This has the approval of the competent authority.

Since the formation of ELS/BSP will be spread over for creation period, the staffs who are inducted from time to time will continue to maintain their lien in the parent cadre until the cadre of ELS/BSP is formed finally by notification of a firm date.
3. The vacation / retention of Railway Quarter if any shall be dealt as per extent rules.
4. The date of joining of the staff should be intimated to this office.
5. Suitable entry should be made in the service sheet of the staff concerned.
6. Railway quarter under employee's possession will be dealt as per extent rules.
7. They should be free from SPE/VIG/D&A cases at the time of release; this should be clearly mentioned in the releasing letter.
8. They are not entitled for any transfer benefits such as transfer pass, grant etc.
9. They should be released in accordance with the instructions contained in railway boards letter no. E(NG)I-2001/TR/16 dated 21.11.2001. Unit incharge of the concerned staff should release the staff with abstract muster roll and proper identification memo in which the LTI, signature & photographs pasted in the release memo of the staff and staff should be advised that he should take another two photographs.
10. Unit supervisor is advised to ensure that the Railway property if any under the possession of concerned staff should be handed over to appropriate authority before release.
11. Transfer of Sri Sunil Kumar Sharma & Kumar Ravi Ranjan, Technician Gr. – III are treated as cancelled against their request application for cancellation.
