6. The reserved category candidate who is considered for promotion against UR by virtue of his/her merit will be set-off against reserved point in future in terms of Esstt Rule no. 72/2017.
7. This has the approval of the competent authority i.e. ADRM (infra)/R on 04-10-2019.

Special Note: Shri N V Kashi Vishwanatham has been declared pass in written Examination but found 'Unsuitable' as per Esstt Rule No 167/09. Hence, he has not been empaneled.
