- 5.The above promotion will be effected from the date of shouldering higher-grade responsibility.
- 6.Option for pay fixation may be exercised within a month as per extent rule if they desire so.
- 7 The above order should be carried out within 30 days from the date of issue of the order. At the end of 30 days, if the above staff has not carried out the promotion order, they should be informed to branch officer that they are being debarred for promotion.
- 8.If the staff have not carried out the promotion order at the same station, the disciplinary action should be taken as per para(iii) of Rule No. 224 of IREM Vol-1.
- 9.If they has/have granted MACP benefits, they will get only new designation and no pay fixation will be done.
