**NOTIFICATION NO. 07/2020**

Sub: Formation of panel for filling up the post of Senior Section Engineer in Pay Matrix Level-7 of RSO & RSM group in Electrical/TRS department of Raipur Division/ SECR.

It is proposed to form a panel for filling up of 05 (Five) posts of Senior Section Engineer in Pay Matrix Level-7 in Electrical/TRS department of Raipur Division/SECR. The break-up of vacancies is as under:

**1. ELIGIBILITY AND SERVICE CONDITIONS OF STAFF:**

- 1.1 Staff who have completed minimum one year service in existing grade are eligible for promotion to the post of Senior Section Engineer but they will be promoted only after completion of two years service in existing grade i.e. JE.
- 1.2 The category of Sr. Section Engineer is classified as Non - selection post, hence staff is to be called in 1:1 ratio. The vacancy is to be filled up by seniority cum suitability with prescribed benchmark.

**2. PROCEDURE FOR SUITABILITY:**

- 2.1 Suitability will be conducted on the basis of scrutiny of service records and grading of APARs for the last three years, D&A clearance.
- 2.2 The candidates has to secure 08 marks out of 15, as aggregate in three years APARs

**3. PROVISION OF RESERVATION :**

- a. SC/ST employee's senior enough to be in the 'UR' block will be adjusted against SC/ST points in case SC/ST points are available to be filled up in the said suitability.
- b. If SC/ST candidates are empanelled/enlisted in a selection/non-selection/trade-test by virtue of general seniority/merit against 'UR' block and no reserved posts exist in the said selection/non-selection/trade-test, they will be set off against a reserved point in future.
