

It has been decided to form a panel for Ex-cadre post of CVI/Traffic, in **Level-7** (Grade pay Rs.4600/-) and VI/Traffic in Level-6 (GP Rs 4200/-) on ad-hoc basis. Options are invited from the eligible staff in the following category working in the same Pay Band and Grade pay or one grade below i.e. in GP Rs 4200/- for CVI/T & in GP 2800/- for VI/T on a regular basis.

The provisional panel will be formed for induction against tentative vacancy of three posts in CVI/T in Level-7 and one post in VI/Traffic in Level-6. However, actual inductions may vary.


The selection will comprise of a written test followed by a viva voce.

Applications of the eligible volunteers should be duly filled up in the enclosed proforma and submitted through proper channel duly forwarded by their Controlling Officer. The Controlling officers shall forward only those applications received within due date to the GM/Vigilance/ERly alongwith the current Vigilance/SPE/DAR clearance and the past vigilance history of each applicant. It may be ensured that only the applications of eligible staff having proven integrity are forwarded.

The applications must be **forwarded by the Branch Officer through associated Personnel Branch** and it should be ensured before forwarding the applications that the candidate, if selected, shall immediately be spared.

It is requested that wide publicity be given so that adequate options are available from the eligible candidates to facilitate proper selection. The applications collected from the optees must be forwarded to this office certifying the information furnished in the applications and should **reach this office latest by 31-01-2020**. Applications received after due date i.e. **31-01-2020** shall not be entertained under any circumstances.
