NOTIFICATION NO.15/2020

Sub: Formation of panel for filling up the post of Technician Gr-III (M/S) in Pay Matrix Level-2 in Electrical/TRS department of Raipur Division/ SECR.

It is proposed to form a panel for filling up of 77 (seventy seven) posts of Technician Gr-III (M/S) in Pay Matrix Level-2 against 50% DPQ in Electrical/TRS department of Raipur Division/SECR. The break-up of vacancies is as under:

1. ELIGIBILITY AND SERVICE CONDITIONS OF STAFF:

- 1.1 Staff who have completed minimum one year service in existing grade are eligible for empanelment to the post of Technician Gr-III (M/S) but they will be promoted only after completion of two years service in existing grade i.e Helper.
- 1.2 The category of Technician Gr-III (M/S) is classified as Non - selection post, hence staff is to be called in 1:1 ratio. The vacancy is to be filled up by conducting trade test.

2. PROCEDURE FOR TRADE TEST:

- 2.1 Trade Test should comprise both oral & practical and may include written test wherever considered necessary.

2.2 Qualifying Marks in the Trade Test would be as follows:

3. APPROVAL OF TRADE TEST ASSESSMENT:

(Authority : PCPO/BSP's Estt Rule No.215/2019)

- 3.1 The actual trade test will be arranged by an Assistant Officer according to the specified trade test. He will assess the results of the trade test, which must be supervised by a supervisor not below the rank of assistant Foreman or equivalent status.
- 3.2 Result of trade test may be approved in the division by the respective Administrative Grade Officers of the department concerned.
- 3.3 The trade test accepting officers are advised to scrutinize the results of the trade test properly to ensure that there is no over-writing/alteration before accepting them, so that manipulations, if any, can be detected and prevented.

4. PROVISION OF RESERVATION :

(Authority : PCPO/BSP's Estt Rule No.215/2019)

- a. SC/ST employee's senior enough to be in the 'UR' block will be adjusted against SC/ST points in case SC/ST points are available to be filled up in the said suitability.
- b. If SC/ST candidates are empanelled/enlisted in a selection/non-selection/trade-test by virtue of general seniority/merit against 'UR' block and no reserved posts exist in the said selection/non-selection/trade-test, they will be set off against a reserved point in future.

Representation/Objections against eligibility list for promotion to the post of Technician Gr-III if any may be submitted to this office within 15 days from the date of issue of this notification, failing which it shall be presumed that there is no representation against the eligibility list and accordingly case shall be processed for Trade Test of the staff concerned for promotion to the post of Technician Gr-III (M/S) in Pay Matrix Level - 2 in Electrical (TRS) Department.
