**NOTIFICATION NO.25 /2020**

Sub: Formation of panel for filling up the post of Senior Technician (M/S) in Pay Matrix Level-6 in Mechanical/C&W department of Raipur Division/ SECR.

It is proposed to form a panel for filling up of 37 (Thirty seven) posts of Senior Technician (M/S) in Pay Matrix Level-6 in Mechanical/C&W department of Raipur Division/SECR.The break-up of vacancies is as under:

**1. ELIGIBILITY AND SERVICE CONDITIONS OF STAFF :**

- 1.1 Staff who have put in a minimum of two years service as Technician Grade-I are eligible for promotion as Senior Technician.
- 1.2 The category of Sr. Tech is classified as Non - selection post, hence staff is to be called in 1:1 ratio.The vacancy is to be filled up by Seniority-Cum-Suitability.

**2. PROCEDURE FOR SUITABILITY:**

- 2.1 Suitability will be conducted on the basis of scrutiny of service records and grading of current year APAR, D&A clearance.
- 2.2 Staff who have been graded 'Below Average' will not be considered for promotion.

**3. PROVISION OF RESERVATION :**

- a. SC/ST employee's senior enough to be in the 'UR' block will be adjusted against SC/ST points in case SC/ST points are available to be filled up in the said suitability.
- b. If SC/ST candidates are empanelled/enlisted in a selection/non-selection/trade-test by virtue of general seniority/merit against 'UR' block and no reserved posts exist in the said selection/non-selection/trade-test, they will be set off against a reserved point in future.


