3. The above panel are provisional subject to free from SPE/VIG/D&A & Court case and punishment of stoppage of increment, reduction of pay etc pending if any against them.
4. Out of 19 vacancies, only 13 staff is available in immediate lower grade, hence only 13 posts will be filled up & remaining posts will be kept vacant due to non availability of staff in Tech - II category.
5. The staff appearing in Sl. 11 (SC) & 13 (SC) are suitable against 'UR' by their own seniority position. They will be set off in SC roaster points in future as per Estt. Rule No. 72/2017.
