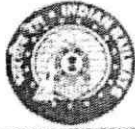

1. The above panel shall be provisional and subject to outcome of pending contempt petition (C) No. 483/2012 before Hon'ble Supreme Court in terms of RBE No. 117/2016 and PCPO/SECR Estt Rule No. 150/2016, 72/2017 & 02/2019.
2. Necessary entry should be made in the service sheet of the staff concerned.
3. The above panel are provisional subject to free from SPE/VIG/D&A & Court case and punishment of stoppage of increment, reduction of pay etc pending if any against them.
4. The name of Sri Gokul Churra, Tech III/OHE/BIA was present in the eligibility list. Published by this office for promotion to the post of Tech -II on 18-12-19. Subsequently the staff was removed from service on 02-12-19 and reinstated in service on 20-02-20 with Punishment of reduction of pay by three stages for a period of 2 years with CE.
5. Out of 15 vacancies, only 12 staff are available with minimum 01 year service in immediate lower grade, hence 03 (UR) posts are kept vacant due to non availability of staff with minimum 01 year service in Tech - III category.
