- 1. It may be noted that this post (ADEN/AXEN) is a safety category post and accordingly candidate is required to qualify the prescribed medical fitness before appearing in viva-voce. Without medical fitness certificate, candidate will not be eligible for attending viva-voce.

He may be directed for medical examination for fitness to Group 'B' (Technical) service immediately and fitness memo to be sent to concerned Personnel Officer for onward transmission to reach this office on or before 12.06.2020
