Ministry of Railways have decided to revise the All India Engine Hour Cost (AIEHC) for recovery of Siding and Shunting charges, w.e.f.18.07.2020 as under-

- 3.0 Costs to be recovered for steam locos wherever in use over Indian Railways shall be identical to that of Diesel Engines indicated above.
- 4.0 These revised costs will remain in force until further orders.
- 5.0 Rounding off of shunting period would continue to be done as per instructions laid down in Para 3.6 of Board's letter No.TC-1/2008/214/1 dated 06.02.2009 (Rates Circular No.14 of 2009, and as amended from time to time).
- 6.0 Action may please be taken to give due notice to the siding owners before introduction of revised Siding and Shunting Charges.
- 7.0 The afore-mentioned instructions will also be applicable for Indo-Nepal Traffic.
- 8.0 This issues with the concurrence of Finance Directorate of Ministry of Railways.
