


NOTIFICATION NO. 44/2020

Sub: Formation of panel for filling up the post of Technician Gr-III/C&W/BIA in Pay Matrix Level-2 against 25% staff qualified quota in Mechanical/C&W department of Raipur Division/ SECR.

It is proposed to form a panel for filling up of 33 posts of Technician Gr-III/C&W in Pay Matrix Level-2 against 25% staff qualified quota in Mechanical/C&W department of Raipur Division/ SECR by calling applications from volunteers from amongst the serving employees i.e. Helper in level-1 working in Mechanical/C&W department of Raipur Division, possessing the educational qualifications and fulfilling the service conditions as detailed below.

The break-up of vacancies is as under:

1. ELIGIBILITY AND SERVICE CONDITIONS OF STAFF :

1.1 All serving Helpers working in Mechanical/C&W department who passed the minimum qualification of 10th class examination with science & mathematics under 10+2 system of education or its equivalent or ITI passed/course completed act apprentice with having two years of regular service are eligible to volunteer for selection.

1.2 The cut-off date for determining the eligibility of staff should be the date of issue of notification. As such the volunteering employees should fulfill the service conditions of age and educational qualification and other service conditions as on the date of issue of this notification i.e. as on **03-07-2020**.

1.3 The staff who are appointed as substitutes and subsequently regularized in a group 'D' posts are required to fulfill the service condition of (02) two years counted from the date of regularization.

Note: In respect of employees who have reported/joined on this division on Inter Railway request transfer/Inter Divisional request transfer on bottom seniority, the service rendered in the old unit will count for the purpose of qualification service for promotion in the new seniority unit provided: -

- He/She is otherwise eligible to be considered for the selection to Group 'C' post as per extant rules; and
- The category in which he/she was working in the old unit is an eligible category for the selection/post in the new unit also.

2. PRE-SELECTION COACHING:

- The period of training is fixed uniformly for 3 weeks.
- The training is mandatory for all SC/ST candidates. There is no need to obtain their willingness/unwillingness for such training.
- The eligible SC/ST candidates coming under zone of consideration in the selection will be spared for such training on full time basis without fail.
- The attendance sheet of SC/ST candidates in the training should be sent to Personnel Branch for confirmation of above.

3. MODE OF SELECTION AND QUALIFYING MARKS.

3.1 Professional Ability: - The professional ability of the employees in the field of selection will be adjudged through written test only. The employees must secure 60% of marks in professional ability.

3.2 The post of Tech Gr-III being a safety one, there will be no relaxation in qualifying marks for candidates belonging to SC/ST community. They have to obtain minimum of 60% in written test & 60% in aggregate.

3.3 The final panel will be drawn up in the order of merit based on aggregate marks of 'Professional ability' and 'Records of service'. However, the employees must secure minimum of 60% marks in 'Professional ability' and 60% marks in aggregate, for being placed on the panel. There will be no classification of candidates as 'Outstanding'.

4. SYLLABUS:

The tentative syllabus is enclosed for wide publication amongst the staff concerned.

5. PROCEDURE FOR WRITTEN EXAMINATION:

- The question paper will be 100% objective Type.
- All the questions will be of multiple choice only.
- To ensure the authenticity of the answers, cutting, overwriting, erasing or alteration of any type in the answer will not be accepted. Zero marks will be given for Answer having correction / over writing.
- There shall be negative marking for incorrect Answers. One third of the marks allotted for each question will be deducted for wrong answers.
- Answer any 100 of the question, 10 questions (optional) will be on Rajbhasa. If any candidate answer more than 100, the first 100 attempted questions will be count.
- All objective type questions should carry equal mark.
- The duration of examination under objective type multiple choice will be 2 Hours.

6.2 It is to be advised to the volunteering staff that there will be no supplementary examination to the absentees, since the selection is by calling volunteers.

7. NOTIFYING TO THE STAFF:

7.1 The controlling officer/supervisor shall give wide publicity of notification to all eligible staff of Mechanical/C&W department of Raipur Division and notification should be displayed at conspicuous place. Staff who are on deputation/leave/sick should also be notified to enable them to submit their applications in time. It should be the responsibility of senior Subordinate/Supervisor to complete the formality in this respect. Any laxity in this regard will be viewed seriously.

8. How to apply:

8.1 The employees should submit the application in the prescribed format through proper channel enclosed as Annexure- 'B'

8.2 They should fill up the application form in their own writing with blue or black ball point pen only.

8.3 It may be noted that all the relevant columns in the application should be filled completely & strike out the inapplicable columns indicating as "NA" and forward duly verified & certified by the controlling supervisors/officers wherever specified in the application or otherwise same will not be considered.

9. TRAINING OF THE EMPANELLED STAFF:

9.1 The empanelled staff possessing the qualification of ITI/Course completed Act Apprenticeship in the relevant trade in the railway establishment may be subjected to trade test and those possessing the same may be promoted as Technician Gr-III in paymatrix level-2.

9.2 If the empanelled staff do not possess the qualification of ITI/Course completed Act Apprenticeship in the relevant trade in the Railway establishment will be imparted training for a period of six months. On completion of the training the staff will be subjected to trade test and such of them as pass the trade test will be promoted as Technician in paymatrix level-2.

10. LAST DATE FOR SUBMISSION OF APPLICATIONS:


The controlling officer has to forward all the applications in one bunch to this office together with DAR/SPE/Vig clearance on or before **12-07-2020**. Applications received after the last date will summarily be rejected without assigning any reason.

The applications received beyond the last date should not be entertained and rejected invariably by the controlling supervisors/officers and same will not be considered.

11. GENERAL INFORMATION:

- a. To attend the above written exam, candidate is advised to attend on scheduled date of exam along with proper identification memo.
- b. Unit incharge is advised to release the staff in time with proper identification memo.
- c. If use any unfair means is noticed from the candidate, they shall be asked to leave the examination hall and has to face action under DAR also.
- d. If any discrepancy is found at any stage in regard to the applicant the candidature is liable to be cancelled at any stage of selection without any information.

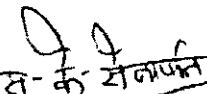
