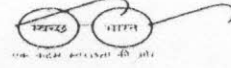




1. THE ENAGAGEMENT IS PURELY ON CONTRACTUAL BASIS FOR THREE (03) MONTHS ONLY FROM THE DATE OF JOINING. THE SERVICE RENDERED AS RE-ENGAGEMENT/ CONTRACT OF PARA-MEDICAL STAFF IS AN ARRANGEMENT FOR MEETING UP THE REQUIREMENT OF THE PANDEMIC SITUATION OF COVID-19 AND IT WILL NOT CONFER ANY RIGHT FOR AUTOMATIC REGULARIZATION/ ABSORPTION IN ANY CIRCUMSTANCES. THE FULL TIME PARA-MEDICAL STAFF WHO ENTERS INTO CONTRACT/ RE-ENGAGEMENT WITH THE RAILWAYS WILL NOT HAVE ANY CLAIM OR RIGHT FOR HIS CONTINUTY IN SERVICE OR AUTOMATIC EXTENSION OF THE TERM CONTRACT/ RE-ENGAGEMENT AFTER EXPIRY/ TERMINATION OF HIS CURRENT CONTRACT. THE RAILWAY ADMINISTRATION HAS FULL RIGHT RESERVED TO DISCONTINUE CONTRACT/ RE-ENGAGEMENT AT ANY STAGE. ALL OTHER TERMS AND CONDITION AS LAID IN RAILWAY BOARD'S LETTER NO- E(NG)II/2005/RC-4/SC/2 DATED 31.03.2020 AND OTHER AS CIRCULATED FROM TIME TO TIME SHALL BE BINDING UPON THE PARA- MEDICAL STAFF.
2. YOUR PAY WILL COMMENCE FROM THE DATE YOU JOIN IN DUTY AT THE STATION TO WHICH YOU ARE POSTED FOR TRAINING.
3. RATE OF REMUNERATION PER MONTH (CONSOLIDATED) SHALL BE AS PER NOTIFICATION P-HQ/RCT/218/PARA-MEDICAL/153 DATED 06.04.2020. DAILY RATE OF DEDUCATION PER DAY FROM THE PAY FOR ABSENCE MAY BE PRO-RATA BASIS.
4. DURING THE PERIOD OF CONTRACT EITHER PARTY (THE PARA-MEDICAL STAFF OR RAILWAY ADMINISTRATION) IS FREE TO TERMINATE THE CONTRACT ON 15 DAYS NOTICE. HE SHALL BE LIABLE TO PAY THE AMOUNT FOR THE REQUIRED PERIOD AS PER PREVAILING RATES.
5. ABOVE CANDIDATE IS DIRECTED TO REPORT TO MEDICAL DIRECTOR, CENTRAL HOSPITAL, BILASPUR FOR FURTHER POSTING ON FULL-TIME CONTRACT BASIS, WHICH WOULD BE GOVERNED BY THE INSTRUCTIONS ISSUED BY THE RAILWAY BOARD FROM TIME TO TIME.
