

4. THE STAFF CONCERNED SHOULD BE FREE FROM SPE/VIG/D&A CASES AND NOT UNDERGOING ANY PUNISHMENT OR STOPPAGE OF INCREMENT ETC.
5. THE PAY OF THE ABOVE STAFF IS TO BE FIXED IN THE HIGHER GRADE IN TERMS OF RULE 1313(1) (A) (I) OF EXTANT RULE VIDE ESTT. RULE NO-138/09 PARA-7. THE OPTION MAY BE EXERCISED WITHIN THE MONTH.
6. NO STEPPING UP OF IN THE PAY BAND OR GRADE PAY WOULD BE ADMISSIBLE WITH REGARD TO JUNIOR GETTING MORE PAY THAN THE SENIOR ON ACCOUNT OF PAY FIXATION UNDER MACPS.
7. DESIGNATION OF THE ABOVE STAFF EVEN AFTER PLACEMENT IN THE HIGHER SCALE AND GRADE PAY WILL REMAIN UNCHANGED.
8. SUITABLE ENTRY SHOULD BE MADE IN THE SERVICE RECORD OF THE STAFF CONCERNED.
