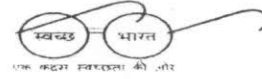

1. THE ABOVE STAFF HAVE BEEN FOUND SUITABLE IN THE SCREENING/SUITABILITY HELD FOR GRANTING FINANCIAL UP-GRADATION UNDER MACPS.
2. MACP SCHEME CONTEMPLATES MERELY PLACEMENT IN THE HIGHER PAY SCALE/ GRANT OF FINANCIAL BENEFITS (BY FINANCIAL UP-GRADATION) ONLY TO RAILWAY SERVANTS CONCERNED ON PERSONAL BASIS AND SHALL NOT AMOUNT TO ACTUAL/FUNCTIONAL PROMOTION OF THE EMPLOYEES CONCERNED.
3. FINANCIAL BENEFITS UNDER THIS SCHEME SHALL BE GIVEN TO THE NEXT HIGHER GRADE IN ACCORDANCE WITH THE EXISTING HIERARCHY IN A CADRE/CATEGORY OF POSTS WITHOUT CREATING NEW POST FOR THE PURPOSE.
4. THE STAFF CONCERNED SHOULD BE FREE FROM SPE/VIG/D&A CASES AND NOT UNDERGOING ANY PUNISHMENT OR STOPPAGE OF INCREMENT ETC.
5. THE PAY OF THE ABOVE STAFF IS TO BE FIXED IN THE HIGHER GRADE IN TERMS OF RULE 1313(1) (a) (i) OF EXISTENT RULE VIDE ESTT. RULE NO-138/09 PARA-7. THE OPTION MAY BE EXERCISED WITHIN THE MONTH.
6. NO STEPPING UP OF IN THE PAY BAND OR GRADE PAY WOULD BE ADMISSIBLE WITH REGARD TO JUNIOR GETTING MORE PAY THAN THE SENIOR ON ACCOUNT OF PAY FIXATION UNDER MACPS.
7. DESIGNATION OF THE ABOVE STAFF EVEN AFTER PLACEMENT IN THE HIGHER SCALE AND GRADE PAY WILL REMAIN UNCHANGED.
8. SUITABLE ENTRY SHOULD BE MADE IN THE SERVICE RECORD OF THE STAFF CONCERNED.
