MACP SCHEME ENVISAGES MERELY PLACEMENT IN THE HIGHER PAY SCALE/ GRANT OF FINANCIAL BENEFITS BY FINANCIAL UP GRADATION TO RAILWAY SERVANTS CONCERNED ON PERSONAL BASIS AND SHALL THEREFORE NEITHER AMOUNTS TO FUNCTIONAL/ REGULAR PROMOTION NOR WOULD ENTAIL REGULAR CREATION OF NEW POSTS FOR THE PURPOSE.
2. PERFORMANCES OF SUCH DUTIES AS ARE ENTRUSTED TO THE EMPLOYEE TOGETHER WITH RETENTION OF OLD DESIGNATION.
3. FINANCIAL UP GRADATION IS PERSONAL TO THE INCUMBENT FOR STATED PURPOSE AND RESTRICTION OF MACP SCHEME FOR FINANCIAL AND CERTAIN OTHER BENEFITS SUCH AS SANCTION OF ADVANCES INCLUDING HBA, ALLOTMENT OF GOVT. ACCOMMODATION, ISSUE OF PASSES ETC DULY WITHOUT CONFERRING ANY PRIVILEGES RELATED TO HIGHER STATUS (E.G. INVITATION TO CEREMONIAL FUNCTIONS, DEPUTATION TO HIGHER POSTS ETC) FINANCIAL BENEFIT UNDER THIS SCHEME SHALL BE GIVEN TO THE NEXT HIGHER GRADE IN ACCORDANCE WITH THE EXISTING HIERARCHY IN A CADRE / CATEGORY OF POSTS WITHOUT CREATING NEW POST FOR THE PURPOSE.
4. DESIGNATION OF THE ABOVE STAFF EVEN AFTER PLACEMENT IN THE HIGHER SCALE AND GRADE PAY WILL REMAIN UNCHANGED.
5. THE STAFF CONCERNED SHOULD BE FREE FROM D&A/SPE/VIG CASES AND NOT UNDERGOING ANY PUNISHMENT OF STOPPAGE OF INCREMENT.
6. SUITABLE ENTRY SHOULD BE MADE IN THE SERVICE RECORDS OF THE STAFF CONCERNED.
