With reference to the above, the written examination of **(04) posts (UR-03 & ST- 01)** for the Group-"B" post of Rajbhasha Adhikari was conducted on **21.07.2020** at Nagpur Division and HQ's Office/SECR. 1. It may be noted that this post Rajbhasha Adhikari is a non safety category post and accordingly candidates are required to qualify the prescribed medical fitness before appearing in viva-voce. Without medical fitness certificate, candidates will not be eligible for attending viva-voce.
2. Controlling Officers of the above named employees are requested to advise them to be in readiness for attending viva-voce at short notice. **They may be directed for medical examination for fitness to Group 'B' (Non Technical) service immediately** and fitness memo to be sent to concerned Personnel Officer for onward transmission to reach this office on or before **07.09.2020**
3. Personnel Officers/Controlling Officers are advised to **send ACRs/APARs for the last five years (i.e 2015-2016 to 2019-2020)/ 2015-16, 2016-17, 2017-18, 2018-19, 2019-20 & updated Service Records** of the above -named employees to this office on or before **07.09.2020** positively. In case ACRs/APARs of any employees are to be requisitioned from other Railways/Divisions/Units, then Controlling Officers may please coordinate and ensure the ACRs/APARs are received in time.
4. Present DAR/SPE status of the employees may also be communicated.
5. The above result is provisional and is subject to final certification/verification of Integrated seniority list based on service record/ related documents.

6. If date of Seniority, Lien, DOB, Community, and date of regular promotion provided by candidates is found to be incorrect, then their candidature is liable to be rejected without information.


