NOTE:

- 1.THE CONTRACT DOCTOR ENTERING INTO CONTRACT WITH THE RAILWAY WILL NOT HAVE ANY CLAIM OR RIGHT FOR HIS /HER CONTINUITY IN SERVICE OR AUTOMATIC EXTENSION OF THE TERM OF CONTRACT.
2. THE CONTRACT DOCTOR WILL BE AT LIBERTY TO TERMINATE THE CONTRACT FOR BETTERMENT OF THEIR CARRER OR ON ANY OTHER GROUNDS BY GIVING 15 DAYS NOTICE TO THE RAILWAY. THE CONTRACT CAN BE TERMINATED BY RAILWAY AT ANY TIME DURING THE CONTRACT PERIOD BY GIVING 15 DAYS NOTICE WITHOUT GIVING ANY REASONS.
3. THE CONTRACT WILL BE TREATED TERMINATED AUTOMATICALLY ON COMPLETION OF PERIOD OF THREE MONTHS FROM THE DATE OF JOINING.
- 4.THE MONTHLY REMUNERATION SHALL BE SA PER RATES DECIDED BY RAILWAY BOARD FROM TIME TO TIME. THE PRESENT RATE OF THE MONTHLY REMUNERATION OF CONTRACT DOCTORS(GDMO) IS AS FOLLOWS:-
