Sub: Filling up the posts of Crew Controller/Loco Controller on tenure basis in Electrical/ OP department of Raipur Division.

1. It is proposed to fill up the posts of Crew Controller/Loco Controller by drafting Loco running staff on tenure basis in terms of Railway Board's letter cited under reference.
2. The vacancies proposed to be filled up are as under:

**3. Eligibility Conditions:**

The loco running staff from the following grades/categories having a minimum of 75,000 Kms of actual driving experience are eligible to volunteer for drafting as Crew Controller/Loco Controller:

- a. Loco Pilot (Mail Express) in Level-6 in 7<sup>th</sup> CPC Pay Matrix
- b. Loco Pilot (Passenger) in Level-6 in 7<sup>th</sup> CPC Pay Matrix
- c. Loco Pilot (Goods) in Level-6 in 7<sup>th</sup> CPC Pay Matrix

4. The eligible employees will be subjected to screening test and those who found suitable in screening test will be drafted as Crew Controller/Power Controller on their existing pay on tenure basis
5. Medically de-categorised Loco Pilots upto A-3 medical classification who have a minimum of 75000 Kms of actual driving experience are also eligible to volunteer for drafting as Crew Controller/Power Controller.
6. The tenure of posting of Crew Controller/Power Controller is three years i.e. three years with a cooling off period of equal duration. However, this condition will not apply to the medically de-categories loco pilots drafted as Crew Controller/Power Controller. Their continuance will depend on their satisfactory performance.
7. The lien and seniority of the loco pilots so drafted will be maintained in their parent cadre from where they have been drafted. They will continue to progress in the running cadre and will be governed by all the terms and conditions of service applicable to running staff including pay and allowances, selection, suitability tests and periodical medical examinations.
8. The Loco-Pilots selected as CC/LC are eligible for payment of Allowance in lieu of Kilometerage of 120 Kms per day at the rates applicable to them.

9. They are not eligible to claim TA/DA and special pay.
10. The eligible staff may apply separately for each post in the enclosed proforma (Annexure-A) and forward their application to this office through Controlling Supervisor/Officer.
11. The filled in application should be submitted to their controlling supervisor on or before **01-10-2020**. The controlling supervisor should forward the applications in one bunch to the controlling officer i.e. Sr DEE/OP/R, as the case may be, on or before **28-09-2020**. The controlling officer has to forward the applications duly certifying that they have 75000 Kms of actual driving experience along with DAR/SPE/VIG clearance, in one bunch in hard and soft copy to Sr DPO/R on or before **01-10-2020**.
