4. The appointment of the above candidates on suitable posts in level-1 (7th CPC) will be subject to requirement of administration and availability of posts. Two candidates each will be posted in BSP/Raipur/NGP Division, as per their merit position/choice.
5. The candidates have to pass the mandatory training, if any, attached to the post.
6. Individual offer of appointment will be sent separately to the selected candidates by division against which the candidates are allotted.
7. The candidates, if appointed, will have to serve S.E.C. Railway for a minimum period of 5 years from the date of posting after training. No any Transfer application will be entertained from them.

While due care has been taken in preparing the result, Railway Recruitment Cell, South East Central Railway, Bilaspur reserves the right to make amendments to the provisional panel at any subsequent stage.
