Sub: Formation of panel for filling up the post of Loco Pilot (Passenger)/Loco in Pay Matrix Level-6 of Electrical/OP department of Raipur Division/ SECR.

It is proposed to form a panel for filling up of 03 (Three) posts of Loco Pilot (Passenger)/Loco in Pay Matrix Level-6 in Electrical/OP department of Raipur Division/SECR. The break-up of vacancies is as under:

1. ELIGIBILITY AND SERVICE CONDITIONS OF STAFF :

- 1.1 Staff who have completed minimum one year service in existing grade are eligible for promotion to the post of Loco Pilot (Passenger)/Loco but they will be promoted only after completion of two years service in existing grade i.e. LP(G) & PDC.
- 1.2 The category of Loco Pilot (Passenger) is classified as Non - selection post, hence staff is to be called in 1:1 ratio. The vacancy is to be filled up by seniority cum suitability with prescribed benchmark.

2. PROCEDURE FOR SUITABILITY:

- 2.1 Suitability will be conducted on the basis of scrutiny of service records and grading of APARs for the last three years, D&A clearance.
- 2.2 The candidates has to secure 06 marks out of 15, as aggregate in three years APARs

3. PROVISION OF RESERVATION :

- c. SC/ST employee's senior enough to be in the 'UR' block will be adjusted against SC/ST points in case SC/ST points are available to be filled up in the said suitability.
- d. If SC/ST candidates are empanelled/ enlisted in a selection/non-selection/trade-test by virtue of general seniority/merit against 'UR' block and no reserved posts exist in the said selection/non-selection/trade-test, they will be set off against a reserved point in future.
