

सं. 2022/ई.एंड आर/1(3)/9 — यह एतद्वारा आम सूचना के लिए अधिसूचित किया जाता है कि परिचालन आवश्यकताओं को ध्यान में रखते हुए, केंद्र सरकार ने पश्चिम मध्य रेलवे और दक्षिण पूर्व मध्य रेलवे के बीच क्षेत्राधिकार सीमा को बदलने का निर्णय लिया है।

पश्चिम मध्य रेलवे और दक्षिण पूर्व मध्य रेलवे के बीच मौजूदा क्षेत्राधिकार सीमा (किमी. 1028.600) को अब न्यू कटनी जंक्शन (एनकेजे)-अनूपपुर (एपीआर) खंड पर स्थित झालवाड़ा (जेएलडब्ल्यू) स्टेशन की ओर पुनर्स्थापित करके किमी. 1027.380 कर दिया गया है। तदनुसार पश्चिम मध्य रेलवे और दक्षिण पूर्व मध्य रेलवे के बीच नई सीमा न्यू कटनी जंक्शन (एनकेजे)-अनूपपुर (एपीआर) खंड पर किमी. 1027.380 पर होगी।

उपरोक्त परिवर्तन तत्काल प्रभाव से लागू होगा।

No. 2022/E&R/1(3)/9—It is hereby notified for general information that keeping in view the operational requirements, Central Government has decided to revise the jurisdictional boundary between West Central Railway and South East Central Railway.

The existing jurisdictional boundary (Km 1028.600) between West Central Railway and South East Central Railway is hereby revised from Km 1028.600 to Km 1027.380 towards Jhalwara(JLW) station on New Katni Jn(NKJ)- Anuppur(APR) section. Accordingly, the new boundary between West Central Railway and South East Central Railway will be at Km 1027.380 on New Katni Jn(NKJ)- Anuppur(APR) section.

The above change will come into force with immediate effect.
