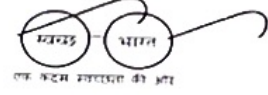

TOTAL =03) (one post reserved for PwBD), (C- category (LD)), posts of ADME/AWM (Gr  
"B") against 70% DPQ of Mechanical Department in SECR will be conducted by  
NAIR/BRC.

Based on willingness received, the provisional list of only eligible candidates  
considered (i.e. Zone of Consideration) for appearing in CBT /written examination is  
enclosed as "Annexure-A". If any candidate is found ineligible at any stage of the  
selection process, his/ her candidature will be rejected.
