
In continuation to the above referred letter at-1, it is to inform that the CBT/

NAIR/BRC.

considered (i.e. Zone of Consideration) for appearing in CBT /written examination is
enclosed as "Annexure-A". If any candidate is found ineligible at any stage of the
selection process, his/ her candidature will be rejected.
