In terms of Railway Board's letter No. 2021/W-1/Genl./Gati Shakti Dated 27-07-2022, it has been decided to fill up following posts in Gati Shakti Unit in Raipur Division of South East Central, Railway by re-engagement of retired staff.

Applications are invited from retired Railway Staff who fulfill the following eligibility conditions for the following posts as indicated below on monthly remuneration basis for the Gati Shakti Unit of Raipur Division of SEC, Railway.

The following terms and conditions may kindly be noted:-

The re-engagement will be valid for a period of one year from the date of engagement and will be extended time to time as per administrative requirements.

1. Detailed notification & application format is available on <https://secr.indianrailways.gov.in> → News/Press Release/Recruitment → Recruitment → Raipur of Retired Railway staff on Raipur Division and application will be submitted through e-mail id: srdporaipur@gmail.com
2. The last date for submission of the application is **15.05.2023**, Any applications received after the dead line will not be accepted.
3. Only retired railway employees are eligible to apply.
4. Re-engagement is for a period of one year.
5. All the Railway Retired Supervisor who have not attended 64 years 6 months as on closing date of notification (to ensure at least 06 months service is available after the re-engagement) for re-engagement purpose will be eligible. No re-engaged employee should continue in service beyond 65 years of age.
6. The Administration is at liberty to terminate the service of the re-engaged employees even before completion of his term in case their work /conduct is found unsatisfactory by giving a notice of 15 days. The re-engaged retired staff should give a notice of 15 days before discontinuing his service.

7. The employees Removed / Dismissed/ Compulsory retired as a result of DAR action or under review are not eligible for re-engagement. Further employees retired under Safety Related Retirement Scheme (SRRS)/LARSGESS are not eligible.
8. Monthly remuneration of retired Railway Supervisors being re-engaged is determined as per Estt. Rule 307/19. The re-engaged employees are entitled only for monthly fixed remuneration i.e. reduction pension from his /her last pay drawn (i.e. Basic +DA) at the time of retirement. The monthly fixed remuneration plus full pension shall not exceed the last pay at the time of retirement.
9. The re-engagement employees will not be eligible for any kind of leave like CL, LAP , Sick leave etc.) for absence if any, appropriate deduction from salary /wages will be made from the monthly remuneration.
10. The re-engagement employees are not entitled for any other benefit or facilities except the monthly fixed remuneration.
11. The retired employee shall execute an agreement to abide by all the terms and conditions of the re-engagement.
12. Re-engagement shall be subject to prescribed medical fitness for the relevant category.
13. Suitability /competency of the applicant shall be adjudged by nominated committed by the way of personnel interview before re-engagement.
14. The duty hours of the re-engaged employees would be 08 hours duty or as required. The duty can be changed as per the requirement of works by the administration with weekly off for one day.
15. Copy of any of the following documents should be attached with the application & it is mandatory.
 - (i) Service Certificate
 - (ii) Pensioner Identity Card
 - (iii) Pension Payment Order
16. While assigning the duties the safety and other operational requirement will be adequately considered.
17. TA /DA is payable as applicable.
