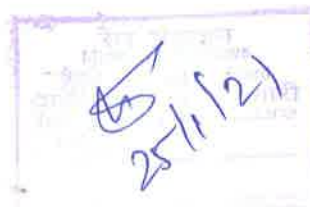

Instructions regarding Rail Good Work Portal on Indian Railways website

1. Rail Good Work Portal has been hosted on the website of Indian Railways at the Railway Board page. The portal can be accessed on the website <http://www.indianrailways.gov.in/railwayboard/> under the tab "For IR Personnel".
2. Purpose of this Portal is to provide an on line platform to all Zones, Divisions, Production Units, RDSO and Central Training Institutes (CTIs) where they can freely share the good works being done by them.
3. GMs, PHODs, DRMs, Directors of CTIs and EDs of RDSO heading Directorates would be given user name and password to upload the good works. CRIS would email the username and password to the authorized users. Once uploaded, the good work can be viewed freely by all on the website.
4. The guidelines for uploading are given on the Portal. While uploading the good work one of the following categories (which best describes the good work) may be selected from the menu: Revenue enhancement, cost reduction, operations improvement, asset management & maintenance, energy conservation/environment improvement, digital initiatives, human resource development, innovative financing, materials management, safety improvement, improving customer experience, project management, other good work.
5. The good work may be supported with pictures/sketches to facilitate appreciation. The name, mobile number and email id of the contact person of the railway unit may be entered in the upload form. This will enable the viewing employees across IR to contact the concerned person to learn more about the good work in which he/she is interested. This would encourage easy and fast adoption and replication of these good works across Indian Railways
5. The blank upload format is printable by all. The objective is that employees can print the blank form and write about the good work done by them and share with concerned officers for considering for uploading.
6. In case of any difficulties related to uploading/viewing or other technical issues related to the Portal please contact CRIS. The contact details are given on the Portal under tab "Contact Us".
